## 2026 Michael J. Casbon Safety Awards

The Michael J. Casbon Safety Award was developed by the NDA Awards Committee, in conjunction with the NDA Safety Committee. This award honors the legacy of the late Mike Casbon. The intention of this award is to honor companies who have demonstrated excellence in safety.

The award includes three sections: lagging indicators, narrative and safety culture, for 32 possible points.

The award is subdivided into three categories based on man-hours per year. Please make sure to select the appropriate category for your company when applying.

Category A – Less than 100,000 man-hours per year Category B - 100,001 to 350,000 man-hours per year Category C - 350,001+ man-hours per year

The deadline to submit this award is January 15, 2026.

Applicants will be required to submit their 300A forms as a supplement to this application by January 15, 2026, in order to be considered for the award.
